Prevention serves community needs by providing programs and services that create and reinforce conditions to promote healthy behavior and lifestyles for the residents of Berkeley County. These include Information, Education Workshops, Problem Identification, Referral, Laws/Community Norms And Coordination of the Berkeley County Prevention Board.

The Berkeley County Prevention Board, along with the Kennedy Center, sponsors three major community events each year.

### 3-D Candlelight Memorial Service

An event to remember victims and their family members who were affected by drunk and drugged driving.

### Family Fest, Picnic in the Park

An annual event held as the Kick-off to Red Ribbon Week to promote Drug prevention.

### Red Ribbon Proclamation Signing

Berkeley County Council, Sheriff, Mayors and Police Chiefs sign a proclamation declaring October 23-31 Drug Prevention Week for their respective municipalities.

In addition, the Prevention Department has two Substance specific grants.

### The Alcohol Enforcement Grant (AET)

Funds the 9th Judicial Circuit AET Team and its member agencies to enforce Underage Alcohol use and sales.

### Partnership for Success (PFS)

Addresses Opioid, Stimulant Misuse and Impaired Driving.

## Finance

Individual arrangements for payment can be made through the Finance office based on a financial assessment and the client's ability to pay. Most private insurance and Medicaid are accepted.

## Adult Services

The Kennedy Center offers a wide range of outpatient services in a safe and supportive environment.

- Biopsychosocial Assessments
- Individual & Family Therapy
- Group Therapy
- Intensive Outpatient Therapy

### Medication Assisted Treatment:

The Kennedy Center recognizes the importance of treating the opioid epidemic. This program provides medication to assist clients with withdrawal symptoms while they attend treatment services. This combination allows the best opportunity for success for our clients.

### ADSAP (Alcohol & Drug Safety Action Program)

The statewide substance abuse program for Individuals who are convicted of driving under the influence (DUI) or driving with unlawful alcohol concentration, individuals referred by the Department of Natural Resources for boating under the influence (BUI), and individuals whose licenses are suspended through the state's Administrative License Revocation (ALR) procedure.

### Drug Court

Drug Court is available for individuals with pending Criminal charges and/or probation violations. Entry into the program requires a guilty plea to charges and/or probation violations with a negotiated sentence and deferral upon successful completion of the program. The program lasts a minimum of 15 months. Upon successful completion of Drug Court, the charges will be dismissed or the probation supervision ended

### SAP Services

SAP (Substance Abuse Professional) evaluates employees who have violated DOT drug and alcohol program regulations and makes recommendations concerning education, treatment, follow-up testing and aftercare.

## Youth Services

Our Youth Outpatient Program offers a wide variety of services to meet the unique needs of adolescents and their families dealing with substance misuse, dependence or related high-risk behaviors.

### Behavioral Health Counseling

Counseling/therapy that utilizes evidenced based models to engage and help clients identify unhealthy behaviors, provide education about the social and mental impact of unhealthy behaviors and provide support with changing unhealthy behaviors and replacing them with healthier ones.

### Outpatient Counseling

Customized for each person based on their individual needs. It can range from individual and/or group counseling sessions. The number and frequency of those sessions will depend on the needs of the client and their families.

### The Bridge Program

Serves both Berkeley and Charleston Counties. This is an intensive program that provides behavioral health services in the community, homes and schools of clients served. Sessions provided can include intensive case management, individual, family and group therapy. To further assist youth in this program, life skills, education assistance and employment services are also provided. One of the primary referrals for this program is the Department Of Juvenile Justice.
